Font size 12 point in Times New Roman font with 1.5-line spacing throughout. The abstract should be limited to 200 words and should contain titles, name of the authors, affiliation, Email Address. All submitted abstracts will be reviewed according to the standard reviewing procedures. The presentation should have maximum of 20 slides. The size of the Poster should be in A2 size (42cm x 59.4cm) for poster presentation. The acceptance of abstract will be intimated through e-mail.

Selected Papers will be Published in Scopus Indexed Journal on Payment Basis.
