- The sanction is issued in exercise of the powers delegated to the council and other terms & conditions laid down in the guidelines of the scheme.
  - 100% grant of the sanctioned amount is being released to Government/Govt. Aided institutions. Utilization Certificate (UC) and other requisite documents are to be submitted within one month of the completion of the project.

#### II. Maintenance of accounts:

- ~~The Council or its nominee shall have the right to check/verify the account to satisfy that the fund has been utilized for the purpose for it was sanctioned.~~
- The date of release of the grant by AICTE shall be taken as the date of commencement of the project. The Principal / Director / Registrar shall intimate about the receipt of the grant to AICTE. Any expenditure incurred prior to the issuance of the approval letter will not be allowed to be adjusted in the grant and if the Institution / University do not take the project work within one month of the receipt of the grant, the approval shall ipso facto lapse.
- After receipt of the grant from AICTE, the Institute shall send a confirmation to AICTE within 2 months of receipt of grant that the sanctioned project has been started/is in progress.

#### III. Refund of grant by way of a demand draft in favour of Member Secretary, AICTE, New Delhi:

- If the college/institute does not have the Letter of Approval (LOA) or Extension of Approval issued by AICTE for the academic year 2019-20, the fund released should be immediately refunded to AICTE with interest accrued thereon.
- If project is not started within six months of the issuance of this Offer Letter, the released amount, along with interest accrued thereon, has to be necessarily returned to AICTE.
- In any case, if the institute is required to refund the grant or interest accrued thereon or balance amount, the amount will be refunded to AICTE.
- It may be ensured that the project is completed within the stipulated time. If the project is not completed in time, no further extension will be granted in any case and institute has to refund the entire amount to AICTE.
- As AICTE needs adequate time for depositing the Demand Draft in the bank, the same be immediately dispatched to avoid any lapse of the validity period.

#### IV. Submission of documents by college/institution after completion of Project/Subsequent years:

- g) Attested photocopies of supporting vouchers/bills of expenditure incurred for the completion of Project.
- h) Photographs of equipment's purchased.
- i) The balance amount of the grant will be reimbursed to the university/institution only on submission of the above documents. On receipt of these documents, the total amount of balance of financial assistance, admissible as per the norms, shall be worked out and grant-in-aid shall be released, as second installment, in favour of the beneficiary institution.

#### V. General instructions

- a) The amount of interest accrued on the grant should be treated as part of the grant to be utilized for that particular project. However, the interest amount accrued along with grant disbursed should not exceed the total grant sanctioned for the project. The Vector Network Analyzer measures the frequency response of a component. The ADS software enables the students and researchers to build their prototypes, test beds and applications that are required for designing a real system. The time domain analysis of signals is not sufficient to measure its characteristics. It is essential to understand the frequency domain analysis of Radio Signals and Applied Electromagnetic with high frequency instruments. Main experimental component of the procured equipment includes understanding of high frequency devices, Antenna concepts and design fields. The system provides support and interface to the industry's standard simulation tools, design environments and community-maintained open source projects. Students can take projects in the upcoming areas like MIMO technology, UWB applications, Vector Signal Generator/Analyzer, Radio Monitoring, Positioning and Localization, Phased array antenna measurements, Ad-hoc Networks and Several other complex radio systems.


**Terms and Conditions for implementation of the project titled "Rural - Urban Connectivity Centres for Technology Dissemination, Research and Livelihood Sustainability: Mushroom Cultivation and Training"**

1. For Permanent, Semi-Permanent assets acquired solely or mainly out of the project grants, an audited record in the form of a register shall be maintained by the Institute. The term "Assets" include (a) the immovable property acquired out of the grant; and (b) movable property of capital nature where the value exceeds Rs.1000/. The grant shall not be utilised for construction of any building unless specific provision is made for that purpose. Full infrastructural facilities by way of accommodation, water, electricity, communication etc., for smooth implementation of the project shall be given by the institute.
2. All the assets acquired from the grant will be the property of TNSCST/DST, Government of India and should not be disposed off or encumbered or utilised for purpose other than those for which the grant had been sanctioned, without the prior sanction of TNSCST.
3. At the conclusion / termination of the project, the Government of India will be free to sell or otherwise dispose off the assets which are the property of the Government. The Institute shall render to the Government necessary facilities for arranging the sale of these assets. The TNSCST/Government of India has the right to gift the assets to the Institute or transfer them to any other Institute if it is considered appropriate.
4. The comptroller & auditor General of India, at his discretion, shall have the right of access to the books and accounts of the institute maintained in respect of the project grant received from the TNSCST/Government of India. Separate accounts should be maintained for which grant is sanctioned by the council for the project.
5. The institute will maintain separate audited accounts for the project. If it is found expedient to keep a part or whole of the grant in a bank account earning interest, the interest thus earned should be reported to the TNSCST and should be reflected in the Statement of Expenditure, The interest thus earned will be treated as a credit to the institute to be adjusted towards further instalment of grant.
6. All the personnel including Research personnel appointed under the project, for the full / part duration of the project, are to be treated as temporary employees and will be governed by the Administrative rules / service conditions (for leave, TA/DA etc) of the implementing Institute. They are not to be treated as employees of the TNSCST/Government of India and will have no liability, whatsoever, for the project staff after completion of the project duration.

For the expeditious implementation of the research project, the Principal Investigator will take the assistance of the institute in the process of selection and appointment of staff and payment to them. Scale and emoluments for the posts not covered under TNSCST are governed by norms prevalent in the implementing Institution or as may be decided in consultation with TNSCST.
8. The TNSCST reserves the right to terminate the project at any stage if it is convinced that the grant has not been properly utilised or appropriate progress is not being made.
9. Investigators wishing to publish technical / scientific papers based on the research work done under the project, should acknowledge the assistance received from DST,GoI/TNSCST indicating the scheme. Investigators are also requested to publish some of the research papers emerging out of the project work in leading Indian journals.
10. If the results of research are to be legally protected, the results may not be published without action being taken to secure legal protection for the research results.
11. For projects identified to have a distinct potential for generating know-how, in the form of product / process that could be protected through patenting, copyrights etc., should carefully follow the "Guidelines / Instruction for Technology Transfer and Intellectual property rights" provided in the Guidelines for implementing Research Projects booklet issued by the DST,GoI.
12. The facility created should be allowed to be utilised by the beneficiaries. Beneficiaries may be charged nominally in consultation with TNSCST. The revenue generated should be utilised for the maintenance of the facility. The facility may also be used by the students/faculties for their study and to understand the technology involved. 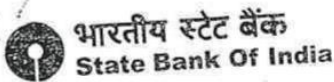
